Imposing Penalties and Measures on a Local Bank Subject to the Supervision of the Central Bank of Kuwait

The Board of Directors of the Central Bank of Kuwait has decided to impose a "written warning" penalty and measures to issue an order and three "financial" penalties totaling 50,000 Kuwaiti Dinar on one of the local banks in the State of Kuwait, in accordance with the provisions of Article (15) of Law No. (106) of 2013 issued with respect to combating of money laundering and terrorist financing, as amended.

The imposition of these penalties and measures comes as a result of the inspection mission conducted on the bank in the field of verifying its compliance with the requirements of combating money laundering, terrorist financing and the financing of the proliferation of weapons of mass destruction in line with the instructions issued by the Central Bank of Kuwait in this regard, as the penalties and measures were imposed as a result of the Violation of Article (Tenth/2/ A , B) and Repeated violation of Articles (Nineth/1, 4 paragraph C, and F) , (Twelfth) and (Thirteenth/1) of the instructions issued on 16/2/2023 regarding combating money laundering and terrorist financing.

The Central Bank of Kuwait always seeks, through its supervisory and regulatory functions, to ensure that all banks and their employees comply with the laws in force in the State of Kuwait, and the regulations and standards approved by it, with the aim of maintaining the transparency and integrity of the banking sector and protecting the financial system of the State.
